

TERMS AND CONDITIONS LIV'N NATURE

1 General

1. These conditions apply to any workshop that Liv'n Nature presents on its website to the person that subscribes through the website for that workshop of Liv'n Nature, hereafter referred to as "Participant".
2. On the Custom Workshop, additional conditions apply, see section 7.

2 Sign up

1. Signing up is always done via the form on the website of Liv'n Nature. After that, the Participant will receive a confirmation of registration and payment instructions.
2. When signing up a minor between 16 and 18 years, telephonic or written consent of the legal representative is necessary.
3. When signing up a minor under 16 years, the legal representative of the minor must also sign up separately as a Participant.
4. As long as the participant has not yet paid for the workshop, the registration is not yet final.

3 Payment

1. The total amount due must be received on the account of Liv'n Nature at least two weeks prior to the course date.
2. The payment must be transferred by making a deposit, unless otherwise specified by Liv'n Nature.
3. After the course fees have been paid, the Participant will receive a confirmation of payment, a description of the exact location where will be gathered for the course and other workshop information.

4 Cancellation by Participant

1. Participation of a workshop can be canceled by the Participant with a full refund of the cost until two weeks prior to its start, by writing Liv'n Nature.
2. Is the workshop canceled by the Participant in between 1 and 2 weeks prior to its start, then the Participant will receive a 50% refund of the cost.
3. Is the workshop cancelled later than one week prior to its start by the Participant, then the Participant will receive no refund of the costs.
4. Cancellation must always be done in writing, for example by means of an e-mail to Liv'n Nature.
5. The workshops Liv'n Nature will not be canceled in case of rain. The only exception to this may be the Custom Workshop, if while making preparatory arrangements was agreed otherwise.

5 Cancellation by Liv'n Nature

1. Liv'n Nature has the right to cancel the workshop up to a week in advance if the number of applications is less than the minimum number of participants for this workshop stated on the website of Liv'n Nature.
2. Force majeure is defined in these terms, in addition to what is included in the law and jurisprudence, as all external causes, foreseen or unforeseen, which Liv'n Nature can not influence, but which make Liv'n Nature unable to give a workshop.
3. Liv'n Nature can cancel a workshop that takes place during the period of force majeure.
4. Liv'n Nature reserves the right to cancel the workshop up to a day in advance in case of extreme weather. In that case, the full paid course fee will be refunded to the Participant.

5. If a Participant causes such hindrance or nuisance that a good execution of the workshop is hampered, this Participant can be excluded from the workshop by Liv'n Nature. In that case, no refund of the course fee is possible.

6 Liability

1. Liv'n Nature is not liable for damages arising from medical conditions or allergies, of which Liv'n Nature was not informed in advance.
2. Liv'n Nature is not liable for damage caused because Liv'n Nature acted upon incorrect and/or incomplete information that was provided by the Participant.
3. Liv'n Nature is not liable for damage / injury caused due to not following the safety instructions of Liv'n Nature.
4. Liv'n Nature is not liable for damage / injury caused if the safety instructions of Liv'n Nature have been followed, but the cause of the damage / injury could not reasonably be foreseen by Liv'n Nature as a logical consequence of the circumstances of the workshop.
5. Liv'n Nature takes no liability for theft or damage to property before, during and after the workshop.

7 Custom Workshop

1. The person who signs up for the Custom Workshop, is for the instructors of Liv'n Nature the contact for the group before, during, and after the activity.
2. The terms and conditions for the Custom Workshop apply to everyone in the group. The person who signs up for the workshop, is responsible for propagating these terms and conditions to his group members prior to, during and after the workshop.
3. The contact person for the group creates an announcement and description of the Custom Workshop for the participants. These can be briefly discussed before notifying participants with Liv'n Nature.
4. The contact person for the group facilitates the transmission of information to the group that is relevant to the workshop. For example, about what equipment the participants have to bring themselves.
5. The person who signs up for the Custom Workshop, is the person who pays for all members of the group.
6. The total price for a Custom Workshop depends on the program duration, the subject, the equipment required, the travel expenses of the instructors and optional preparation time.
7. Once Liv'n Nature and the applicant have made an appointment for the Custom Workshop, Liv'n Nature will send an invoice to the Participant.
8. For nature-related associations, Liv'n Nature applies a discounted rate for the Custom Workshop.
9. When 4 to 8 participants are subscribed by the contact person, Liv'n Nature reserves the right to add participants. If 8 or more participants are subscribed by the contact person, then the contact person may choose to keep the workshop private.
